The Franklin County Conservation District is a political subdivisions of state government, established in 1941 and charged with the conservation of the natural resources of Franklin County. Our primary operating funds are provided exclusively through county ad-valorem tax funds, as appropriated through the Franklin County Commissioners; and Kansas Water Plan funds, as outlined in K.S.A. 2-1907C. The public can also contribute to the conservation district through memorial, honorarium and other gifts to help enhance our mission of conserving our natural resources for the future.



Conservation provides economic and environmental benefits direct to Franklin County and all residents; both urban and rural. Voluntary conservation practices enhance and protect water quality, and soil health, for community health and environmental benefits and now is your opportunity to support our mission.

We offer several options for you to support conservation.

Your tax-deductible contributions will make a difference in general operations and public information and education programs focused on promoting conservation of natural resources for the future. From school programs for students, to professional development workshops for educators; to field days for local farmers and ranchers to learn new soil health practices.
